**CANVASSING BOARD BUSINESS:**

- ❖ Meeting called to order at 8:00 a.m. by Commissioner Johnson. Supervisor Walker noted meeting was properly published and introduced Canvassing Board members, counsel and staff.
- ❖ There was no public comment.
- ❖ Commissioner Johnson moved to begin the Logic and Accuracy testing. Second by Ms. Cox. Motion carried unanimously. While the equipment was being prepared, Mrs. Walker explained the L&A testing and purpose. All 16 devices for the Special Election will be tested, along with tabulating equipment and Clear Ballot Audit Scanners.
- ❖ Attorney Hedges summarized rules of decorum.

- ❖ Ms. Cox moved to begin testing of equipment. Second by Commissioner Johnson. Motion carried unanimously.
- ❖ Board Members reviewed and signed off on zero tapes for equipment being tested.
- ❖ Logic and Accuracy testing of equipment commenced. Upon completion, the Board signed off on verification tapes. The Board retired to tabulation room and observed testing of tabulation equipment and Clear Ballot Audit equipment. Reports were printed, reviewed, and signed off on by the Board. Voting equipment was re-sealed and seal numbers verified by Commissioner Johnson.
- ❖ Ms. Cox moved to certify the L&A testing. Second by Commissioner Johnson. Motion carried unanimously.
- ❖ SOE Walker announced next full Canvassing Board meeting is January 13, 2026, at 5:00 P.M., with pre-scanning meeting scheduled for 1/12/26.
- ❖ Mrs. Walker announced that today's testing documentation would be placed in Box with Seal #100-001 and placed in cage under Seal #0648341. The report containing serial numbers used in the L&A tests will be entered into the record.
- ❖ Ms. Cox made motion to adjourn the meeting. Second by Mrs. Walker. Motion carried unanimously.
- ❖ Meeting adjourned at 9:59 A.M.
