VOTE-BY-MAIL BALLOTS HAVE BEEN MAILED FOR THE
AUGUST 20, 2024, PRIMARY ELECTION

Vote-By-Mail Ballots for the August 20, 2024, Primary Election were mailed to 31,198 voters with requests on file. Voters should expect their ballots in their mailboxes this week.

Voters who wish to request a Vote-By-Mail Ballot for this Election can do so by visiting www.slcelections.com or by contacting the St. Lucie County Supervisor of Elections office at 772-462-1500. The deadline to request a Vote-By-Mail Ballot is August 8, 2024, at 5:00 pm. Supervisor Walker would like to remind voters that they may drop off their ballots inside any of the four (4) Supervisor of Elections Offices locations listed below, during normal business hours, starting now through 7:00 pm on Election Day.

Gertrude Walker, Supervisor of Elections stated, "If voters are returning their ballots by mail, the ballot should be mailed at least a week prior to Election Day to ensure it is received by the deadline."

Curbside Vote-By-Mail Ballot drop off will be available during the Early Voting Period at Secure Ballot Intake Stations at all Early Voting Sites and Supervisor of Elections office locations. Early Voting will be held from August 10, 2024, until August 17, 2024, from 10:00 am until 6:00 pm daily at the following locations:
