The following is the schedule of the meetings for the 2018 General Election. All meetings will be held at the Supervisor of Elections Office in the Election Center, 4132 Okeechobee Road, Fort Pierce.

**\*Wednesday, October 17, 2018 – 7:00 am** – Convene for Logic and Accuracy Pre-Test of voting equipment (101.5612 FS)

**\*\*Cancelled\*\* Monday, October 22, 2018 – 7:00 am – Tentative** – Reconvene for Logic and Accuracy Pre-Test of voting equipment, (101.5612 FS) for precinct ballots not received in time for 1st L&A.

**\*Tuesday, October 23, 2018 –7:00 am** – Public Inspection of absentee ballots first 15 minutes, reconvene to canvass Absentee Ballots (101.68 (2) FS) – May begin at 7 a.m. on the 15th day before the election.

**\*Thursday, October 25, 2018 – 8:00 am** – Public Inspection of absentee ballots first 15 minutes, canvass Absentee Ballots.

**\*Monday, October 29, 2018 – 8:00 am** – Public Inspection of absentee ballots first 15 minutes, canvass Absentee Ballots.

**\*Wednesday, October 31, 2018 – 7:00 am** – Public Inspection of absentee ballots first 15 minutes, canvass Absentee Ballots.

**\*Saturday, November 3, 2018 – 7:00 am** – Public Inspection of absentee ballots first 15 minutes, canvass Absentee Ballots.

**\*Tuesday, November 6, 2018 - 1:00 pm & 5:00 pm** – Reconvene to canvass Absentee Ballots, precinct election returns and provisional ballots (101.068 FS.)

**\*Thursday, November 8, 2018 –3:00 pm** – Reconvene to canvass Provisional Ballots, (No later than 5 p.m. on the 2nd day after any election (101.048 FS).

**Saturday, November 10, 2018 – Noon – Tentative** meeting if not signed prior – Noon deadline for county canvassing boards to file 1st Unofficial Results of General Election with the Department of State (Section 102.141, FS) – No later than noon of the 4th day after a general election.

**Tentative – Scheduled in the event of a Machine or Manual Recount**

**Sunday, November 11, 2018 – 7:00 am – Thursday, November 15, 2018 – 3:00 pm**– Reconvene for Logic and Accuracy Pre-Test of Voting equipment (101.5612, FS) and conduct a Machine Recount if ordered, (102.141(7) FS). The County Canvassing Board or the State Canvassing Commission responsible for certifying the results of the vote shall order a machine recount.

**Manual Recount** (102.166 FS) – Will follow the completion of machine recount if needed.

**Thursday, November 15, 2018 – 3:00 pm** – Deadline for county canvassing board to file 2nd Unofficial Results of General Election with the Department of State, if recount was conducted (Section 102.141, FS) – No later than 3 p.m. of the 9th day after the election.

**\*Friday, November 16, 2018 – 3:00 pm – 5:00 pm** – Reconvene to canvass 10 day overseas ballots (Rule 1S-2.013, F.A.C.) – Ballot postmarked or signed and dated no later than the date of the Federal Election and received no later than 10 days from the date of the election. Sign Certification and Report on Conduct of Election and Conduct the Post-Election Audit, **if no recount.**

**Sunday, November 18, 2018 – NOON** – Deadline for county canvassing boards to submit Official Results to the Department of State for the General Election (Section 102.112, FS) – Noon on the 12th day following the election.

**\*Monday, November 19, 2018 – 10:00 am – Noon – Tentative** - Reconvene to conduct an automated audit of the voting system used in precincts, immediately following the certification of each election (101.591, FS).
